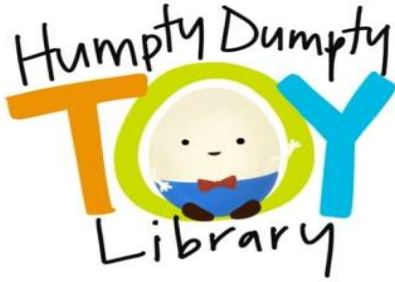

# MEMBERSHIP CONDITIONS

*Please read the following borrowing conditions carefully.*

### CLEANING OF ITEMS PRIOR TO RETURN TO THE TOY LIBRARY:

As members of the Humpty Dumpty Toy Library, you are responsible for the items you borrow and must clean all items before you return them to our Toy Library. Where possible, please wash borrowed items with hot soapy water. If water is likely to damage the borrowed item, please clean only with a damp cloth or antiseptic cloth.

### VOLUNTEERING TO ASSIST IN THE TOY LIBRARY:

The Toy Library is run by the Humpty Dumpty Toy Library Coordinator. Over the course of your membership, if you can volunteer your time to assist at the library with placing toys back on the shelves, cleaning toys, stock taking or other duties as needed by the Karratha Family Centre, Humpty Dumpty Toy Library Coordinator please email:

### PERIOD OF LOAN OF TOYS AND OTHER ITEMS:

Humpty Dumpty Toy Library Members may borrow **four (4) items for two (2) weeks**. Toys may be renewed once ONLY, but please email the Humpty Dumpty Toy Library Coordinator your intention to renew.

### LATE RETURNS:

**TOYS MUST BE RENEWED BEFORE THEY ARE OVERDUE.** Overdue toys will incur a fine of \$15 per week. This fine will need to be paid BEFORE any further borrowing is permitted.

### CARE OF BORROWED ITEMS:

Please take care to ensure toys aren't left outside in the Pilbara elements, as this significantly reduces their lifespan. Do not leave water in the water tables overnight. In the event of a cyclone, YOU are responsible for securing any outdoor toys.

### RETURNING ALL ITEMS BORROWED:

Each member is responsible for counting the pieces of each toy BEFORE it is borrowed or as soon as you get home. If any pieces are missing or damaged, please inform the coordinator **IMMEDIATELY** that there are missing or damaged items, not after the toy is returned, or you may be held responsible.

### DAMAGED OR MISSING ITEMS:

Any toys brought back with missing pieces will be renewed to you, to give you additional time to find the missing pieces before replacement costs are charged.

Damaged Items - We understand that sometimes accidents do happen. If an item is damaged/lost or pieces are missing, as a condition of your membership of the toy library you will be responsible to cover the cost of the replacement. This will be assessed at the time by the coordinator. If missing pieces/damage to the toy renders it unusable, you will be asked to replace the toy. This will also be assessed at the time by the Humpty Dumpty Toy Library Coordinator.

## **Humpty Dumpty Toy Library Waiver, Release and Indemnity for Bicycle and Scooters**

***Please read the following carefully***

The Humpty Dumpty Toy Library ("Provider") is pleased to make bicycles and scooters available to subscribers ("the Service"). As a subscriber to the Service you acknowledge that there are dangers and risks inherent with bicycle and scooter riding ("the Activity") to which any child under your supervision ("Your Child") may be exposed. The Provider does not provide protective clothing or bicycle helmets and it is your responsibility to ensure that Your Child wears a helmet at all times and is otherwise appropriately attired when participating in the Activity. You agree that Your Child will participate in the Activity at your own risk. You also agree to voluntarily assume responsibility for supervising the Activity and any injury, death or property damage you or Your Child may suffer or cause as a result of participating in the Activity. To the maximum extent possible at law, you (both in your personal capacity and on behalf of Your Child) agree to release, hold harmless and indemnify the Provider and its respective officers, employees, servants, agents, and contractors (the "Indemnified Persons") against all actions, claims, suits, costs, expenses, demands and damages suffered or incurred by the Indemnified Persons or any one or more of them by reason of, or in respect of, or in any manner whatsoever arising out of, or caused by, your use the Service on the express condition that the Provider: (a) will, under no circumstances be liable or responsible in any manner whatsoever for any death, loss, accident, damage or injury to you, Your Child or any of your servants, agents, contractors, visitors, or invitees or any other person whatsoever ("Related Party") which may happen as a result of your use of the Service or Your Child participating in the Activity; and (b) will not incur or be under any liability whatsoever to you, Your Child, or to any Related Party for any loss, damage or injury to or in respect of any of your property or of any Related Party's property. The Provider is not liable to you, Your Child or any Related Party in respect of any indirect or consequential loss. For the avoidance of doubt, 'consequential loss' means loss or damage arising from a breach of contract, tort (including negligence), under statute or any other basis in law or equity of an indirect or consequential nature including, but without limitation, loss of profits, loss of revenue, loss or denial of opportunity, loss of goodwill, loss of business reputation, future reputation or publicity, damage to credit rating and indirect, remote, abnormal or unforeseeable loss, or any similar loss whether or not in the reasonable contemplation of the parties .
